<u>Directions:</u> From NY State Thruway (Rochester) – Exit 41, Rt. 414 South to 318 East. Left onto Rts 5 & 20, Right onto 89 South to Ithaca. Left on West Buffalo St., Right on N. Fulton St., Left on W. Seneca (Rt. 79 East – follow it through town and up the hill), left on 366 (Mitchell St, stay on 366, becomes Ithaca Rd.), Right on Pine Tree Rd.

From Route 81 (Cortland) - Route 13 West to Route 366 (Dryden Rd.), turn left. Left on Pine Tree Rd.

From Auburn – Route 38 South, Right on Route 366, Left on Pine Tree Rd.
