I am pleased to inform you that your paper, "LESS is More: The Efficacy of Literature-based Elementary Social Studies (LESS) Program on Students' Reading Comprehension," submitted for consideration for the 2010 AERA Annual Meeting has been accepted. Congratulations on this accomplishment. AERA received more than 10,000 submissions this year. To ensure the highest quality papers presented at the Annual Meeting, your submission was reviewed by three or more highly qualified reviewers serving on a review panel constituted by the Division H - Research, Evaluation and Assessment in Schools/Section 1: Applied Research in the Schools. Reviewers' comments are now available on the Online Program Management (All Academic) System for your use.

The AERA meeting offers a number of session formats to feature high quality research and scholarly work. Your paper has been placed in a Roundtable Session session titled, "Scaling-Up Reading Comprehension Interventions". Each format involves different expectations about the mode of presentation (see AERA website). The program schedule, which will include information on the date, time, and location of your session, will be available in late January.

Please keep in mind that authors whose paper has been accepted for the AERA Annual Meeting are required to upload their full paper to the All Academic System no later than April 9, 2010. The initial submission will constitute the final paper unless you upload a revised paper by the deadline. The All Academic System will reopen in late January so that you may upload a copy of your final paper. Access to uploaded papers is available to all participants in the assigned session.

AERA in addition encourages authors to participate voluntarily in the AERA Online Paper Repository. You already had the option to indicate your preference upon

submission of your paper. If you did not elect the option at the time of submission and would like to do so, you will be instructed on how to do so when you receive notification that the system is open to upload your final paper.

Note also that the Association strongly encourages authors to be attentive to the accessibility of their presentations. The practices recommended therein benefit all attendees with and without disabilities. AERA's goal is to cultivate a universally accessible environment.

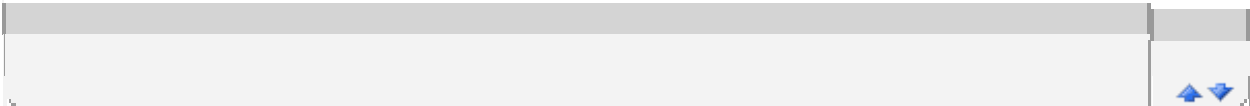
